### ARREST OF AUTO MOBILE (BIKES) THEFT GANG BY MIYAPUR PS

The Sleuths of Miyapur Police Station have made strenuous efforts and apprehended Automobiles (Bikes) theft gang who committed multiple bike Offences in CyberabadCommissionerate and Sangareddy Dist.



#### Accused Details:

- 1: Nalam Durga Srinivas Sai Kiran age 23 yrs, R/o. Narayanapuram, Rajamahendravaram, AP.
- 2: Gottapu Leela Sai, age 21 yrs, R/o. Narayanapuram, Rajamundry, AP.  
**(Accused 1 and 2 were arrested by Miyapur Police)**
- 3: Puramsetti Vijay Siva Sai Prasad, age: 25 yrs, R/o. Jaggampeta, East Godavari, AP( **Arrested by Anakapally District Police**)
- 4: Geddam Praveen @ Bunny age: 25 yrs, R/o Devaguptam Kasi Peta, Allavaram, East Godavari. AP( **Absconding**)

**Facts of the case:**

On receipt of a complaint about theft of KTM DUKE motorcycle from his residence the staff of Miyapur Police worked out on the clues, identified the above motorcycle offenders' gang and apprehended the accused.

**Criminal Background of the accused:**

The accused Nalam Durga Srinivas Sai Kiran, Gottapu Leela Sai, Puramsetti Vijay Siva Sai Prasad and Geddam Praveen @ Bunny hails from Rajamundry, Andra Pradesh and are close associates. They have a criminal background.

**Modus Operandi:**

In order to earn easy money, Nalam Durga Srinivas Sai Kiran hatched a plan to commit theft of highend bikes from parking areas during night hours within the Cyberabad Commissionerate and Sangareddy district. KPHB (11), Ameenpur (3), Chandanagar (3), Gachibowli (2) Miyapur (1) and RC puram (1).

As per their plan, the accused intended to start a second-hand spare parts wholesale shop at their native place.

The accused persons came from their native place, visiting the colonies during night hours, and committing theft of high-end motorcycles parked in front of residential houses, apartments, or shops, by breaking locks. The accused are changing the engine numbers and chassis numbers for not identify its original owner.

**SEIZED ITEMS:**

1. Bikes (21)
2. Tool Kit (1) (to remove the stolen bike spare parts)

3. One Letters set (to make the engine and chassis number)

**Good Work:**

The case was successfully detected, and the accused were apprehended by the Crime Staff of Miyapur Police Station, under the supervision of Madhapur DCP Riti Raj, IPS, Madhapur Addl. DCP Uday Reddy, and Miyapur ACP Ch. Y. Srinivas Kumar.

The public is hereby advised to take necessary precautions to safeguard their two-wheelers. They are also advised not to park vehicles outside their houses and to ensure the installation of CCTV cameras in their residential premises. Whenever vehicles are parked outside, they should be parked only in authorized parking areas. It is further advised to remain vigilant and report any suspicious movement or activity immediately to the nearest police station or by dialing 100.
