



PRESS NOTE

Arrest of (02) Drug Peddlers, (01) Transporter and (03) Consumers during a raid on Rave Party in Gachibowli PS limits, Cyberabad - Seized 20 grams of Cocaine, 08 Ecstasy Pills (20 grams) and 3 grams of MDMA



The sleuths of **Eagle Telangana** along with **Gachibowli Police, Cyberabad** on credible information conducted a joint operation and raided on a party organized at Rajeshwari Nilayam Service Apartment, Kondapur and seized 20 grams of Cocaine, 08 Ecstasy Pills (20 grams) and 3 grams of MDMA.

THE DETAILS OF THE ACCUSED ARRESTED ARE :

- 1) **Teja** Age: 28 Occ: Cloud Kitchen Business at Pragathi Nagar N/o Veditreswaram, Ravulapalem Mandal, East Godavari. (Peddler)
- 2) **Vikram** S/o Satyanarayana Reddy Occ: Poultry Farm Business R/o Sherlingampally N/o Jonnada (V) East Godavari Dist., AP. (Peddler)
- 3) **Manne Neelima** Age: 41 Occ: Housewife R/o Narsingi Hyderabad. (Consumer)
- 4) **Chandhan** Age: 20 Occ: Pursuing Engineering 3rd Year in Bangalore R/o Karnataka (Transporter)
- 5) **Purshotham Reddy** Age: 36 Occ: Wines Shop Business at Kondapur R/o Raja Rajeshwari Nagar, Kondapur Hyd. (Consumer)
- 6) **Bhargav** S/o Sri Balreddy Age: 31 Occ: Software Engineer R/o Cyber Meadows, Sherlingampally. (Consumer)
- 7) **Rahul** @ Sonu R/o Bangalore (Supplier)

The accused Teja, Vikram and Neelima are native of Rajamundry and common friends. All of them are having the habit of consuming Cocaine which gave them the reason for meeting quite often. During one visit to Bangalore, Teja chanced upon one **Rahul** @ Sonu R/o Bangalore who was supplier of Cocaine. Since then, Teja started procuring Cocaine from Rahul and along with Vikram and Neelima used to consume together in Rajamundry.

It so happened that Teja, Vikram and Neelima had to shift to Hyderabad for better professional prospects. They started taking service apartment on rent in Kondapur and meet there regularly and consume Cocaine. The cost of the Cocaine used to be borne by all the consumers and Teja used to send the money to different bank accounts given by Rahul for each transaction.

VIKRAM:

The accused Vikram is having friendship with Surya of Malnadu restaurant and Rahul of Kanvera Farm House. On 01-01-2024 Vikram & Chisty were arrested by Dichpally Police at Idalwai Toll Plaza on his return from New Delhi to Hyderabad in car after collecting 12 grams of Cocaine from one Nigerian Mike (who is known to Rahul) and sent them to jail (Cr.No.01/2024 of Dichpally PS). In this case Rahul was shown as absconding but later produced on PT warrant after he was arrested in Malnadu Restaurant Case in Cr.No.02/2025 of Cyberabad Narcotic PS. He got married in the year 2016 and blessed with a baby girl. Due to his drug consuming habit their relations strained and she is staying away from him.

On credible information, the Eagle Telangana along with Gachibowli police raided the service apartment and took Vikram along with others who gathered to consume drugs into custody.

TEJA:

He is the kingpin who procures Cocaine from his known source **Rahul** @ Sonu R/o Bangalore and organises meeting of all the consumers and he consume Cocaine together. In the new year celebrations on 31.12.2023 one Manideep R/o Rajahmundry arranged Rave Party at Goa and invited Teja & Neilima, where the both were initiated by Cocaine in that Party. Teja will collect money from all the consumers and send it to Rahul. Teja and Neilima along with Vikram attended the Farm house of Manideep at Rajahmundry in many occasions for consumption of Drugs with Manideep.

Teja is also has the habit of taking IV injections for enhancing the skin glow. He came to know that all the celebrities use **Glutahione vitamin** for enhancing their skin glow. When Teja browsed in Internet for Glutahione, he found that one brand **GLUTAX 5GS** is the best brand, checked for its price and it was costing Rs.40,000/- in Hyderabad while the same product was costing Rs.11,000/- in Bangalore. So, Teja ordered it through Rahul so that he can get it for Rs.11,000/-. So, whenever he used to order for GLUTAX, Rahul used to send Cocaine concealed in those boxes. Two or three times Teja received the Cocaine parcel through DTDC Courier and he went to AVA Road branch, Rajamundry and collected these parcels. Neelima tested positive for 3 types of drugs, Teja tested for 5 different types of drugs and the other three tested positive for one type of drug. Chandan was not found positive for any type of drug.

SEIZURE:

20 grams Cocaine

08 Ecstasy Pills weighing 20 grams
3 grams MDMA

In recent times we have seen several youth/students getting addicted to Drugs, committing crime and involving in other anti-social activities. Several families have become victims of this menace.
